SUBJECT: MEDICAL CERTIFICATES

Following a meeting held on Thursday 10 September with the participation of school managers in the area, of a representation of Medical Executives from the Prevention Department of the ASUR and a of a representation of Pediatricians of free choice, procedures are communicated which have to be followed in case of absence of pupils. In case of:

- absence due to reasons other than illness (sporting commitments, family reasons, holidays ...): the school must be informed about it in advance and this kind of absence must be justified upon return;
- absence due to removal of the pupil from school because of illness: after following the whole procedure indicated in the Higher Institute of Health document, the pupil will return to school only with a certificate from the General Practitioner or the Free Choice Pediatrician;
- absence following an illness, attributable to COVID-19, manifested at home: it is recalled that students must stay at home in case of symptoms attributable to COVID-19 (by way of example and not limited to: body temperature above 37.5 ° C, cough, difficulty breathing, etc.);
- the student's parents must report the absence from school for health reasons and follow the procedure set out in the document. Upon return, the pupil will go to school with a certificate from the General Practitioner or the Free Choice Pediatrician;
- absence for health reasons NOT attributable with absolute certainty to COVID-19 (by way of example and not limited to: pain in the teeth, trauma ...): upon return, the parent must attach self-certification (on model available on the website in the Parents section) which certifies, under its own responsibility, that the absence was caused by health reasons not attributable to COVID-19.
